Additional space will be available in multiple units at a fee of \$190 for the weekend. Twelve (12) **PREMIUM** spots, the first 12 spaces available for vendors, will be available on a first come, first serve basis to vendors for \$260 per area, per weekend. There will be no charge for setup on January 23, with the exception for prepaid electric if needed. Additional tables can be provided by the Bayfront Convention Center for a fee of \$10 per table. Please note that the venue charges an additional \$100 for the weekend if your booth is selling food items for humans as they consider this competition with their concession sales. All vendors are required to be loaded up and departed by 7pm on Sunday, January 25.
